7.1 Charitable carnival

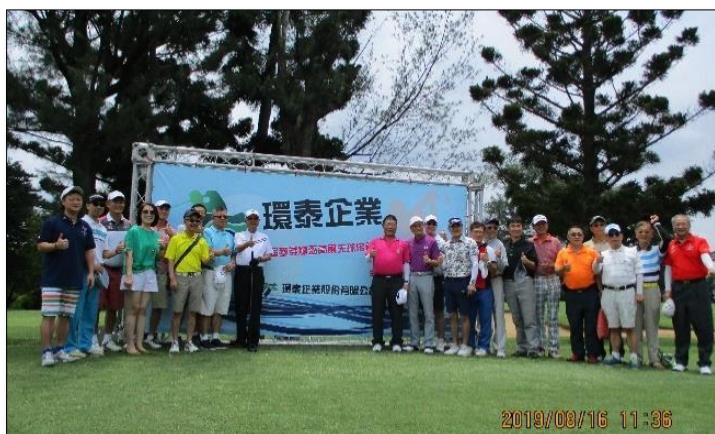
Taoyuan family fund provides diverse services such as economic, educational, medical, recreational, psychological, and behavioral counseling to assist disadvantaged families.

In November 2019, Taiwan Fructose participated in the Taoyuan family fund charitable carnival. In the carnival, we adopted a booth selling customer product such as snow cake, pineapple cake, fragrant cake, etc. At the same time let consumers know which raw materials are made of, and achieve promotional effects. This event provided nearly 1,000 disadvantaged families with materials and parent-child education. Through the implementation of carnival employees gradually gathered centripetal force and deeply understood the meaning of social responsibility.



7.2 Maltose cup golf charity event
